Thank you for choosing to send your child to St. Catherine's School. Catholic education is a decision that demonstrates your commitment to the spiritual, educational, physical, and emotional well-being of your child. St. Catherine's School is committed to assisting you in developing the whole child and helping them reach their full potential in Christ. We look forward to working with your family for many years to come.

Completed registrations are to be returned at the Annual General Meeting (AGM) meeting by 7:00 p.m. on Wednesday, March 11/26.

Catholic Independent Schools presently receive government funding which is 50% of the cost to educate a student in one of the Langley public schools. Students must attend school for a total of 600 hours by May 15<sup>th</sup>. Those who do not have the required number of hours because of sickness are also eligible for funding, provided the absences from school are authenticated by the signed note from parents at the time of the sickness. An extended vacation may result in partial loss of funding. Consequently, parents are advised that the loss of funding must be made up by them.

The 2026/27 tuition and registration fees are as follows:

Please refer to our pre-payment tuition fee requirements, as follows:

We require two months of pre-payments in addition to regular tuition payments from September to April. This two-month pre-payment and the regular monthly payments will equate to the entire 10-month school year. Only in grade 7, when your family leaves the school will tuition not be debited from your account in May and June and your pre-payment will no longer be applicable.

### Pre-payments

Tuition for **May 2027** will be debited from your account on May 1/2026.

Tuition for **June 2027** will be debited from your account on June 1/2026.

Registration fees and Activity fees will be included with your first tuition fee payment in May 202 – please read the Pre-Authorized Debit Form carefully. We also accept pre-payment for the entire year's tuition fees in advance. A Family Rate is available for families with students at St. Catherine's School and at St. John Brebeuf High School. The Family Rate was established by St. John Brebeuf feeder parishes to assist parents with the costs of providing their children with a quality Catholic education. The following family rate applies to St. Catherine's Elementary School families with three or more children attending both St. John Brebeuf High School and St. Catherine's Elementary School.
